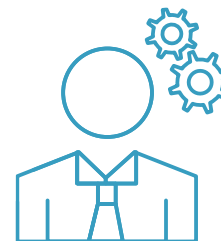

## Inspections, Audits & Shutdowns

If you aren't concerned about State & Federal compliance you should be. The FMCA reported four million commercial vehicle inspections, performed thousands inspections and shutdowns with a reported 88,000 carriers closing in 2023.

Violations typically trigger fines and lead to fleet audits that in addition to random, safety, IFTA and other audits.

Audits can shut down a fleet for days and typically major violations are caused by employee ignorance, negligence or outright fraud which the company owner is responsible.

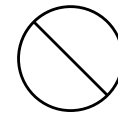
If these violations are discovered due to an accident with a fatality major fines, shut down and civil and criminal liability are very real.
